- For your organization's protection, we ask that page three be notarized.

If your organization currently does not accept payments via ACH, we suggest you consider doing so for the following reasons:

- You will get paid faster! You will see an electronic payment in your account in no more than three business days!
- Reduction of paperwork! There is no need to scan checks or take them to your bank, which reduces the demand on your Accounts Payable staff.
- Better communication. Receive a confirmation email containing the details of what was paid as soon as the payment has been made.

Please let me know if you have any questions. We are looking to implement this new system of payments as soon as possible and feel that it offers our vendors a variety of benefits.
